## **FOUNDATION FEE**

- Foundation Check Cashing 1% or minimum of \$1.00/Fee charged if less than 50% of the check is deposited
- Foundation Fee: \$3.00 per month if your account and/or household falls below \$250 in total relationship dollars, as measured by the combined average daily balance of deposits and loans at month end
- Exemptions and Clarifications: Members under the age of 25 are exempt from the Foundation Fee. Members must notify RRCU should they wish to link "household" accounts/assets together to meet the minimum relationship requirements. An example of this would be pooling total relationship dollars from multiple accounts that have the SAME MAILING ADDRESS. Also, new memberships are exempt during the first three (3) months of membership.

## **MONEY MARKET ACCOUNT FEES**

- Minimum Balance \$15.00 if minimum average daily balance is not met
- Excessive Withdrawal \$15.00/Withdrawal if more than 3 withdrawals per month

## **CHECKING REBUILDER ACCOUNT FEES**

- Monthly Service \$10.00/Recurring Monthly Charge

## **FRESH START CHECKING ACCOUNT FEES**

- Monthly Service \$10.00, on the 1<sup>st</sup> day of each month once open for 30 days.

## **CASHBACK CHECKING PLUS ACCOUNT FEES**

- Monthly Service \$10.00, on the 1<sup>st</sup> day of each month once open for 30 days.

## **EFT FEES**

- ACH Overdraft \$25.00
- ATM Transaction \$1.50 for each ATM transaction at ATMs not owned by the Credit Union
- ATM POS Transactions \$1.00
- Card Replacement \$5.00
- Debit Card Overdraft \$25.00
- PIN Reissue \$1.00
- Foreign Currency Transaction 1.1% of Total
